Example of Cost Calculation, November 2009

The present cost of buy-in is determined by the above formula to be the replacement value of \$1,711,740.00 divided by 459 parcels to obtain a COST of \$3729.28.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Irish Beach Water District hereby orders, effective immediately, that the cost to participate in the IBWD System for immediate or future water connections by property owners who have created new parcels within the District (i.e., re-subdividing) and others who own adjacent property (i.e., annexation) shall be the COST indicated in the above equation. Each added parcel shall be subject to paying the benefit assessments applicable to current property owners as determined at the beginning of each fiscal year by the Board of Directors.
